

Waiver, Indemnification, and Medical Treatment Authorization

1. In consideration for receiving permission for my child to participate in the **STEM Hub program** (the “activity”), which is sponsored by Texas A&M University at Qatar, I release, waive, discharge, covenant not to sue, and agree to indemnify Texas A&M at Qatar, Texas A&M University, The Texas A&M University System and its Board of Regents, and their members, officers, servants, agents, volunteers, and employees (“Releasees” or “Indemnitees”) from all liabilities, claims, demands, injuries (including death), or damages, including court costs and attorneys’ fees and expenses, that my child may sustain while participating in the activity, while traveling to and from the activity, or while on the premises owned or leased by Releasees, **including injuries resulting from the sole, joint, or concurrent negligence, negligence per se, statutory fault, or strict liability of Releasees.** I understand this waiver does not apply to injuries caused by intentional or grossly negligent conduct.
2. I am aware that there are inherent risks to my child and others involved with the activity, including but not limited to tripping, first degree burns, dehydration, and I choose to allow my child to voluntarily participate in the activity with knowledge that the activity may be hazardous to my child and to the person and property of others. I acknowledge there may be physically strenuous activities. I know of no medical reason why my child should not participate. **I agree to indemnify Indemnitees** from all liabilities, claims, demands, injuries (including death), or damages, including court costs and attorneys’ fees and expenses, which may occur to my child, other participants, and third-persons as a result of my child’s participation in the activity, **including injuries resulting from the sole, joint, or concurrent negligence, negligence per se, statutory fault, or strict liability of Indemnitees.**
3. I understand that Releasees do not maintain insurance covering any circumstance arising from my child’s participation in the activity or any event related to that participation. As such, I am aware that I should review my personal insurance coverage. Texas A&M at Qatar seeks a waiver of claims as additional consideration for the right to participate so Texas A&M at Qatar, a governmental unit of the State of Texas, U.S.A., can (a) provide the activity at the lowest possible cost to participants; and (b) provide access to a greater number of participants by expending limited resources on program materials rather than on liability insurance.
4. I intend that this agreement bind my family and spouse, if I am alive, and my heirs, assigns, and personal representatives if I am deceased, and be governed by the laws of the State of Texas, U.S.A.
5. I understand Releasees cannot control all of the risks associated with the activity and Releasees may need to respond to accidents and potential emergency situations. Therefore, I consent to any medical treatment that may be required, as determined by medical professionals, during my child’s participation in the activity with the understanding that the cost of any such treatment will be my responsibility. I agree to indemnify Indemnitees for any costs incurred to treat my child, even if an Indemnitee has signed hospital documentation promising to pay for the treatment due to my inability to sign the documentation. I further agree to release, waive, discharge, covenant not to sue, and agree to indemnify Releasees from all liabilities, claims, demands, injuries (including death), or damages, including court costs and attorneys’ fees and expenses, that may be sustained by my child while receiving medical care or in deciding to seek medical care, including while traveling to and from a medical care facility, **including injuries resulting from the sole, joint, or concurrent negligence, negligence per se, statutory fault, or strict liability of Releasees.** I understand this waiver does not apply to injuries caused by intentional or grossly negligent conduct.
6. I have read this agreement, understand it, and sign it voluntarily; Texas A&M at Qatar has not made and I have not relied on any oral representations, statements, or inducements apart from the terms of this agreement. I execute this agreement for full and adequate consideration intending to be bound by it now and in the future. I understand I can choose not to sign this agreement and free myself from its terms and the associated risks of the activity by simply not allowing my child to participate in the activity and choosing some other activity that has a lower level of risk.
